- 1. 2022 Marion County Fair Dates: June 24th-July 3rd 2022
- 2. Vendor space fees for 2022 Marion County Fair \$350 before April 15, \$50 after. 10' minimum for fees
- 3. Acceptance of this agreement obligates the assignee to pay the total amount due
- 4. No sub-letting permitted
- 5. Cancellation; Seventy-Five (\$75) Dollar cancellation fee within Sixty (60) days of the
- 6. Vendor must provide a Certificate of Insurance with minimum coverages of \$1,000,000 per and \$3,000,000 aggregate with The Marion County Fair listed as additionally insured. Insurance can be purchased for \$250 for the duration of the fair.
- 7. Spaces are based on a first come basis and seniority. The Marion County Fair Director will be the final say on location disputes or direction.
- 8. Only One (1) stand per numbered space
- 9. Absolutely no disrespectful language or gestures will be permitted toward any other person
- 10. No use of loud speakers/PA
- 11. Vendor agrees to be open during fair hours and abide by set-up/tear-down guidelines
- 12. Trash & debris will be collected nightly and taken to the designated area
- 13. Vendor is restricted to selling only items listed on their agreement
- 14. No silly string, laser lights or weapons of any kind may be sold or utilized
- 15. Two (2) fair passes will be provided for each vendor space utilized
- 16. Any beverage listed under the Fair contract, must be purchased from the Fair
- 17. Serving cups, other than "specialty beverages" will be purchased from the Fair
- 18. Absolutely no anchoring by, modifying or marking of the floor around the vending space
- 19. Camping request should be made directly to the Fair office prior to arrival. Space is limited so the earlier you reserve the better
